
GETTING STARTED WITH A BY-NAME LIST - ONTARIO COMMUNITY OF PRACTICE CALLS

New Resource: 211 Ontario Dashboard



211 Ontario Data Dashboard

- Needs identified for calls to 211
- Unmet needs where 211 did not have the resources/referral to provide to the client
- Can be broken down by region, city, age gender, language

Data for advocacy

Housing is the 3rd highest need for calls to 211 (11%), but the highest unmet need due to capacity/waitlist; no resource to meet need; not eligible

Data for improvement ideas

- Data on housing needs in your community to show strengths or gaps in BNL coverage and awareness of Access Points
- Regional data broken down by city to inform or coordinate outreach coverage
- Data on unmet needs as a tool to approach or strengthen partnerships with local 211 partners






In talking to BFZ-C ON communities in 2021 and 2022 we found that...

People experiencing homelessness on BNLs are often not getting access or prioritized for Community Housing.

There are often concerns about having the appropriate level of housing stability supports in place for those who do move into Community Housing.



Priority Alignment

Province of Ontario

Community Housing Renewal Strategy seeks to:

- Improve waiting lists and help those most in need
- Better connect people to housing assistance and supports that are responsive to their complex and changing needs
- Make sure people experiencing homelessness obtain and retain housing

ON Service Manager BNL 2022 Guidelines:

- Requires Service Managers to have a consistent, fair, and documented process to prioritize people in need of housing and supports, based on assessed need
- Majority of people in the Service Manager area who are experiencing homelessness should be included on the BNL

CAEH & ON Communities

- CAEH goal is to end homelessness in Canada
- ON communities aim to reduce homelessness by connecting people on their By-Name List with housing resources. Community Housing is one of those resources.



Linking By-Name Lists and Community Housing could lead to...

- Reductions in homelessness
- More housing resource options for appropriate matches
- Clarity and consistency in the definition of homelessness
- Streamlined intake and application processes
- Comprehensive By-Name List and Centralized Waiting List data
- Further learning on ways to improve provincial policy

- Improved data collection and analysis of homelessness inflows and outflows with respect to Community Housing
- Drawing on case management supports for people housed in RGI units off the BNL toward greater stability
- Improved coordination between Community Housing and homelessness teams as these are separate divisions in some Service Manager areas




Sept and Oct 2022 BFZ-C Peer Calls

About Grey & Bruce County

- Grey and Bruce have partnered for the local Coordinated Access
 System and BNL
- The combined population is just over 160,000
- As of December 1st, 2022, Grey and Bruce had 223 households actively experiencing homelessness within the counties.
- 175 (78%) of these households are experiencing chronic homelessness





 Sustaining a 10% below baseline reduction in chronic homelessness since Feb 2019!





Guelph-Wellington

High-level overview of current status of BNL/homelessness and Community Housing/CWL priority	Local Priority Policy for homelessness to offer every 10th (1:10) CWL unit to someone on the BNL. Requires that the person has intensive case management supports. This only applies to County RGI housing stock not all housing providers within the County. CWL annual updates for anyone on the BNL are completed internally to ensure applications are not cancelled. Regularly review CWL and BNL and work with community partners to ensure CWL applications are completed.
Do you have plans to change what this currently looks like?	Have discussed setting a ratio for County affordable housing units.
What would this <i>ideally</i> look like in the next few years to support BNL reductions, if you had a magic wand	Everyone on the BNL who can live independently is on the CWL. The ratio for unit offers would be 1:2 or 1:5 and apply to all social housing providers (RGI and market rent) and affordable housing units in the County. Increased tenant supports at all buildings to support all tenants and dedicated clinical team to respond to escalating support needs to maintain housing stability.
Barriers to achieving the ideal that you want to discuss with other communities	Stigma around BNL. Concerns that adequate supports are not available to support individuals on BNL. Access to timely clinical supports. Additional funding would be required to ensure individuals on BNL are supported.
